

County of Santa Barbara Annual Transient Occupancy Tax Report

Fiscal Year Ended June 30, 2004

Santa Barbara County — Unincorporated Area

Hotels/motels located in the unincorporated area of Santa Barbara County are required to collect a 10% room tax from their guests and report the collections and submit the taxes to the County Treasurer/Tax-Collector. This Transient Occupancy Tax (TOT) is deposited in the County General Fund when received and is for the County's discretionary use.

TOT generated in the unincorporated area reached \$4.9 million during fiscal year 2003-04. The Montecito area had a decline of 2.1% from the previous fiscal year, but still accounted for nearly 47% of the county's total TOT revenue for unincorporated areas. Revenue generated in the City of Goleta experienced very little change in the past fiscal year, while the Goleta Valley area continued to see significant increases primarily due to the increasing popularity of the El Capitan Campgrounds. Goleta Valley taken as a whole including the hotels in the City of Goleta yielded an increase of 1.1% over the prior fiscal year. Out of the seven hotels in the Santa Ynez area, six demonstrated significant increases over the previous fiscal year, producing an 11% increase, while total North County TOT revenue declined by over 7%. In Santa Barbara County, total TOT revenues generated for fiscal year 2003-04 increased ½% from fiscal year 2002-03.


Countywide Transient Occupancy Taxes


In 1963, local governments were given the power to tax on the privilege of occupying a room or rooms for a period less than 30 days in a hotel, inn or house located in their jurisdiction. In Santa Barbara County, each occupant is currently required to pay a tax currently in the amount of ten percent of the daily rent charged by the operator. The taxes are applied to room sales and then submitted to the jurisdiction in which the hotel is located. The City of Santa Barbara increased their tax from 10% to 12% after the passage of Measure B2000 effective January 2001 to fund Clean Water and Creek Restoration Programs.

Room sales countywide reached \$251 million in fiscal year 2003-04. Countywide room sales grew 1.6% in fiscal year 2002-03 and 1.1% in following 2003-04 fiscal year.

North County/South County

Santa Barbara County currently contains a total of 173 hotels and motels throughout both the north and south regions. With the addition of 13 south county bed and breakfast locations, the county generates TOT revenues from 186 applicable businesses within county lines. Currently, hotels and motels located in north county cities and unincorporated areas account for 22% of the county's total hotel/motel room sales of \$251 million for the 2003-04 fiscal year. Hotels, motels, and bed and breakfasts located within south county cities and unincorporated areas currently account for 78%, or \$195 million, of the county's total hotel/motel room sales. The City of Santa Barbara stands as the south county's biggest contributor with 50%, while Santa Maria and Solvang each contribute 30% of total north county sales.

UCSB Economic Forecast Project predicts the current tourism industry downturn, which has caused significant decreases in both Santa Maria's and Santa Barbara's total hotel/motel room sales, to continue into the next few years. The addition of the Carrillo Hotel in Santa Barbara by 2005 will generate additional TOT revenues for the City of Santa Barbara. In contrast, the TOT will not be applicable to room sales at the newly built Chumash Hotel located on the Chumash Reservation.
