# County of Santa Barbara Annual Transient Occupancy Tax Report



## Fiscal Year Ended June 30, 2009

## **Countywide Transient Occupancy Taxes**

In 1963, local governments were granted the power to tax the privilege of occupying a room or other living space in a hotel, motel, inn, tourist home, or other lodging (such as campgrounds) for 30 days or less. The transient occupancy tax (TOT) is collected by the operator and then remitted to city finance departments or the County Treasurer for the unincorporated area. The transient occupancy tax is currently 10% (12% for the City of Santa Barbara) of the daily rent.

The transient occupancy tax reached \$31.6 million in fiscal year 2008-09, an 8.3% decline from 2007-08. The unincorporated area generated \$6.4 million, while the incorporated cities received the largest share of TOT at \$25.2 million.

- 60% of TOT generated in the City of Goleta goes to the City.
- 40% of TOT generated in the City of Goleta goes to the County.
- For hotels/motels opened after February 1, 2002, 100% of TOT generated in the City of Goleta goes to the City.


## **TOT Highlights for FY 2008-09**

#### Cities

- TOT generated in the cities reached \$25.2 million, a decline of 7.6% from the prior year.
- The City of Santa Barbara, arguably one of the most beautiful cities in the United States, generated 46% of the total TOT earned in the county.


## Unincorporated

- The unincorporated area generated \$6.4 million in TOT, an 11.1% decline from the prior year. The largest declines occurred at the premier destination resorts.
- The Montecito area generates about 52% of the TOT generated in the unincorporated area; the dominant generators in that area being the Four Seasons Biltmore and the San Ysidro Ranch.



## Transient Occupancy Tax Growth / Decline — Unincorporated Areas

In fiscal year 2007-2008, the County's TOT growth rate began to progressively weaken as we approached the end of the fiscal year. In October of 2008, the County began to see the first troubling signs of an economic downturn as TOT revenues began to consistently decline. As fiscal year 2008-2009 continued, the revenue decline rate became more pronounced; some months had a 25-30% revenue decline when compared to the same months in the prior fiscal year. Except for a weak 4th quarter, unincorporated Goleta performed extremely well during the current economic downturn.



## TOT Revenues by Geographic Area North County/South County

Santa Barbara County currently contains an estimated total of 187 hotels and motels throughout the north and south regions. Including 50 vacation rentals and bed & breakfast locations, the county generates TOT revenues from 237 applicable businesses within county lines.

#### South


- South county cities and unincorporated areas accounted for 76%, or \$24.0 million of the county's total TOT.
- During fiscal year 2008-2009, TOT revenues fell by 9.0% in the south county.
- The City of Santa Barbara accounted for 60% of the south county area's TOT revenues.

#### North

- North county cities and unincorporated areas accounted for 24%, or \$7.6 million of the county's total TOT.
- In the economic downturn, the north county fared better than the south county; during fiscal year 2008-2009, TOT revenues only fell by 6.6%.
- The City of Solvang accounted for 29% of the north county area's TOT revenues.

## Forecast — Unincorporated Areas

It is our expectation that the revenue rate of decline will stabilize during the middle of the 2009-2010 fiscal year. As we approach the end of the 2009-2010 fiscal year, we anticipate the beginning of a modest recovery.
